# THE TICKET'S "TIGER'S EXPERIENCE" SWEEPSTAKES OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WJRW-AM, WBBL-AM, and W291DJ ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 60 Monroe Center St. NW Suite 300, Grand Rapids, MI 49503, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **The Ticket's "Tiger's Experience"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
